### When Is Case Management Appropriate?

Injured persons should be evaluated for medical case management intervention when:

- There are multiple providers involved.
- The injured person has a significant pre-existing medical history or previous injuries.
- Treatment is delayed due to injured persons lack of understanding or engagement in inappropriate treatment.
- The injury involves a major joint that limits movement and/or functional ability.
- Patient's psychosocial status needs to be assessed. For example, does the injured person live alone? Does the person have, for example, cognitive limitations?
